5/24/2017 12 Noon Room 412	New Committee on Human Services The Interagency Council on Homelessness Youth Strategic Plan: Comprehensive Plan to End Youth Homelessness In response to the End Youth Homelessness Act of 2014, the ICH has led the development of the Comprehensive Plan to End Youth Homelessness (CPEYH). The CPEYH is the District's first ever strategic plan focused on unaccompanied minors and Transition Age Youth between ages 18 and 24. The plan was unanimously approved by the members of the ICH this past winter, and is scheduled for a public release in May. The purpose of this roundtable is to discuss the issue of youth homelessness in DC, including what the ICH learned during the plan development process, as well as strategies the District must implement in the coming years to ensure the community is positioned to address the housing needs of vulnerable youth and support their successful transition to adulthood.
